COMPLIANCE TESTING & INSPECTIONS

Remote Area Group has developed an App to provide you with an efficient and productive schedule so that we minimise the amount of time in your workspace so you can continue on as business as usual. For many of our clients, they also arrange an after-hours inspection and testing schedule to avoid disruption during operational hours.

Our reports are detailed and are submitted to you within 24 hours. Each report includes photographs of failed items and details all items that fail the visual inspection and testing and are quarantined by our technicians.

If your organisation has specific Work Health and Safety guidelines for failed items our team will adhere to those directions.

Portable Fire Equipment Testing

We inspect and service all portable fire safety equipment including fire extinguishers, fire hoses, fire blankets, smoke alarms. We also ensure that all signage and placement of equipment are up to current AS1851-2005 standards.

Scale and Measuring Instrument Validation

Remote Area Group individually test and report on all scales, issuing a 'Test Certificate' to ensure your scales are accurate. Each scale has a series of weights starting at just 10 grams placed in 4 multiple locations on the scale. Each result is recorded against the scales MPE (Maximum Permissible Error) and shown in the Test Certificate. Each scale then has an accuracy test sticker attached.

Vehicle and Asset Inspection Reports

If you remotely manage a fleet of vehicles, you will immediately see the benefits of Remote Area Group performing our scheduled condition reports on a range of plant, equipment and vehicles. Our thorough checks include tyres, lights, safety equipment, exterior and interior condition, MVR registration and inspection expired dates, we record the hours and km's and take photos.

TESTING & TAGGING

Our testing and tagging technicians thoroughly inspect each item of portable electronic equipment in the workplace. Inspections are completed to detect existing faults and be the foundation of an ongoing inspection program. Your regular safety check program also acts as a comprehensive asset location report for your company for insurance and maintenance purposes.

All electrical tests conducted by Remote Area Group are in compliance with Australian Standard AS/NZS 3760:2010 and are carried out by competent staff. Visual and electrical testing will identify problems such as:

- ✓ RCD trip times and faults
- ✓ Faulty wiring
- Damage from exposure to moisture, chemicals and the weather
- ✓ Current leakage
- ✓ Earth faults
- ✓ Insulation resistance
- Exposed and damaged wires and cords
